Due to changes in the PCA Assessment methods; which came into effect with the release of the 2013 Syllabus of Instruction, written exams have been replaced with workbooks. Your examiners, would like the **completed workbooks and application form sent/given to the State Coach Coordinator, by the date advertised** allowing assessors adequate time to review them. Books will be return to candidates in a timely manner to allow a minimum of two weeks revision for candidates prior to the practical examination.

Workbooks must have all activities completed, and signed off by coach. In particular, ensure that pages which ask for photos, diagrams, samples etc. are completed correctly.

As a guide, the practical assessment will take 3-4 hours plus breaks, depending on candidates on the day. The State coach coordinator will contact you closer to the date regarding proposed timetable and equipment requirements i.e. dressage / flatwork arena, show jumping arena, cross country, some games equipment and adequate area to conduct a hand gallop in safety.

Please ensure all candidates present on the day of assessment with the following:

- Grooming Kit
- First Aid Kit (Up to C* Standard)
- Bandages and padding to demonstrate travel bandaging (travel boots not acceptable)
- Horse rug with leg straps and front buckle
- Personal Water bottle
